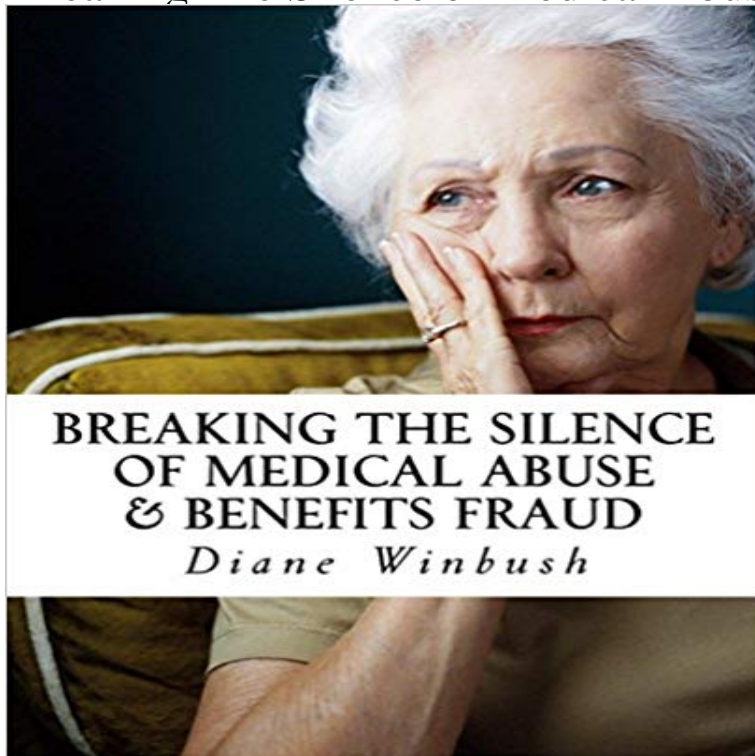


# Breaking The Silence of Medical Abuse & Benefits Fraud
